### Abridged CV of Eugene Kruger

Born: 19 December 1943

Matriculated: Afrikaans Hoër Seunskool, Pretoria (1960)

I was trained during military service as a pilot in the South African Air Force and after obtaining SAAF wings in 1964 was posted out to 4 Squadron to serve as a fighter pilot (CF) flying mostly Harvards and Impalas mk 1 and mk 2 (single seater) until 1984.

I completed my law studies at the University of Pretoria in 1970 and after completing my articles was admitted as an attorney and conveyancer in February 1970 and I have been practicing in this capacity since then.

I obtained the two year post graduate Higher Diploma in Company Law at the University of Witwatersrand in 1988.

After the implementation of the new Companies' Act I obtained a certificate in Business Rescue Practice (NQF Level 8) from the University of South Africa in July 2012.

I practiced in all fields of the law ranging from Criminal Law to Administrative Law, specialising in Immigration Law, Liquor Law and for the past 15 years concentrated on Company Law, Commercial Law and Property Law.

Served in a variety of commissions, boards, boards of directors, school boards and on several occasions acted as a mediator in disputes.

I also served for a period of approximately 25 years as a member of the Synodal Law Commission of the Dutch Reformed Church and also as a member of the Synodal Appeal Commission.

During 2014 I was elected to the board of directors of the Silver Lakes Home Owners Association in the position of Vice Chairman which position I presently still hold. In this capacity, I was involved in a variety of contracts and negotiations on behalf the Home Owners Association. For the past year, I have also served as Chairman of the Country Club committee comprising of members of the Golf Club, the Clubhouse and the restaurant management. During this period the restaurant was fully commissioned, finally had been reached in regards to the move of the Pro Shop to a different premise, and the building of new halfway house had been finalised which should be completed by July this year. I may just add none of these projects would have been finalised without the enthusiastic drive and inputs from the present chairman and the board of directors.

I am married to Mariaan and we have four children and eight grandchildren. Three of my children are living in Pretoria and one in Stellenbosch. We have been living in Silver Lakes for the past 8 years.

Voltooi regsstudies aan die Universiteit van Pretoria 1967 en na afloop van die leerklerskap word ek toegekaat as prokureur en aktevervaardiger in Februarie 1970

Verwerf 'n 2jarige Hoër nagraadse Diploma in Maatskappyreg aan die Universiteit van die Witwatersrand

Verwerf na inwerkingtreding van die nuwe Maatskappywet 'n sertifikaat in Besigheidsreddingspraktyk (NQF vlak 8) in Julie 2012

Praktiseer aanvanklik in alle velde van die reg van kriminele reg tot administratiewe reg, met spesialisvelde in Immigrasie reg, drankangeleenthede en die afgelope 15jaar maatskappyreg, kommersieelereg en eiendomsreg.

Dien oor die jare in verskeie rade, kommissies, direksies, skoolrade en mediasies. Ek was vir bykans 25 jaar lid van die Sinodale Regskommissie van die N G Kerk en ook lid van die Sinodale Appelkommissie.

Gedurende 2014 word ek verkies tot die direksie van die Silver Lakes Huiseienaarsvereniging in die posisie van vise voorsitter welke posisie ek tans nog beklee.
